

PRE-SHIPMENT INSPECTION

Pre-Shipment Inspection (PSI) are all activities relating to the verification of the quality, the quantity, the price: including currency exchange rate and financial terms, Customs valuation and classification of goods to be exported to the territory of the User Government. PSI is a part of supply chain management and an important and reliable quality control method for checking quality of the goods when clients buy from the suppliers and vendors.



LOGPERTS provides PSI services as part of governmental requirements for trade of goods to ensure that imported goods comply with predefined specifications and fully checked against purchase order.

LOGPERTS will be your eye at the time of purchase or shipment.

PSI ACTIVITY CONSISTS OF

- Quantity, Packing and Marking check,
- Quality Control,
- Document Review, Invoice check, Packing List Accommodation, Test Reports Validation and so forth.
- Verifying compliance with the standards as mandated by the destination country.
- Inspection Certificate (IC) & Verification Of Conformity (VOC)

Suggesting results of the PSI process is satisfying, then a certificate of compliance of the goods with relevant standards and requirements will be issued.

At higher level, PSI services are combined with controlling of delivery and production dates to ensure the goods reach in end user's hand well in time. This is called expediting which will be well-handled via our professional team.

PRICE VERIFICATION

In some cases all shipping documents and the invoice must be carefully reviewed, and the accurate value and relevant customs tariff code are assigned to the goods subject to PSI. Such process is referred to as price verification. Danzheh assures the customer (whether import or export party) will enjoy a smooth customs procedure considering expertise, precise and proficiency of our team.



LEGAL VALIDATION CHECKING

Supplier Verification audit checks your potential suppliers against certain internationally recognized standards. Vendor validation is the process that confirms a supplier as a legitimate entity. It can save your company significant money by ensuring that you are not contracting with fraudulent vendors and that your existing vendors have not been renamed, relocated, or gone out of business.
